

Contest Rules

The following are general contest rules that cover most contests and promotions conducted by Valley Broadcasting LLC station KQYZ (Q98). Some individual contests may have additions or subtractions that would be linked through said contest.

1. Eligibility

A. Valley Broadcasting LLC contests are open to all legal U.S Residents except full or part-time employees of Valley Broadcasting LLC, its subsidiaries, their families, participating sponsors and promotional partners. Employees of other radio stations in the Grand Forks market and the members of their immediate families are ineligible to win.

B. No purchase is necessary to play and win.

C. Only one prize winner per household every 30 days unless otherwise specified.

D. Persons must be at least 18 years of age to play, unless specified otherwise.

E. No Purchase Necessary. Void where prohibited.

F. No prior employees or people that have been employed by Valley Broadcasting LLC within twelve months of contest date are eligible.

G. To participate, contestants should call or text the phone number mentioned on the air, unless otherwise specified. In most of the Valley Broadcasting LLC area this is a free call and does not require dialing an area code. If you doubt, check with your local telephone service provider. Standard message and data rates may apply. Valley Broadcasting LLC is not responsible for delayed, incomplete, or misdirected text messages or online entries

2. The Prizes and Taxes

A. Values are subject to change at discretion of Valley Broadcasting LLC and all parties involved.

B. Prizes are non-refundable and non-transferable.

C. NO SUBSTITUTIONS ALLOWED.

D. Failure to claim prize within 30 days may result in forfeiture.

E. Winner is solely responsible for:

1. Transportation to and from any location, unless specified otherwise by Valley Broadcasting LLC.

2. All taxes incurred on all prizes won.

3. Providing Valid Identification in order to claim prize, travel or fly, within or out of the United States.

3. Winner Release

By playing this contest, contestants give Valley Broadcasting LLC permission to use his or her names and/or any likeness in any photographs, print, video, or audio tapes for publicity purposes with no further compensation.

5. Claiming the Prize
